Office Order

As CLB cease to exist and NCLT starts functioning, the existing cadre posts of ICLS in CLB (JAG-1, STS-4 and JTS-3) stands temporarily transferred to Hqrs/field offices of MCA along with the incumbent thereon. The incumbent officers shall continue to work in NCLT/NCLAT on temporary basis till further orders.
