- 8. The technical bid shall mandatorily contain the following:
 - a) The Agency shall furnish the registration details and the license renewal details with documentary proof.
 - b) The agency shall furnish the five years minimum experience details with the documentary proof.
 - c) The Agency shall furnish the service details in two esteemed organization as on 31.03.2017 with a minimum bill of Rs.2,00,000/- with documentary proof.
