
OFFICE MEMORANDUM

Subject : Final Seniority List of Company Prosecutor, Group B as on 01.01.2013

The undersigned is directed to circulate the final seniority list of Company Prosecutor of this Ministry as on 01.01.2013. This is also placed in MCA Website (Employees Corner/Seniority List).

2. As on date, against the sanctioned strength of 30, only 17 are in position. Therefore, controlling officers, in the interest of their offices, may propose appointment of STA/JTA with graduate/post graduate degree in law, as STA cum Ex-officio CP or JTA cum Ex-officio CP. This proposal has to be approved by the Ministry.

3. For 13 vacancies, the DR requisition is pending with UPSC. Another proposal for creation of 30 Company Prosecutors is pending with D/O Expenditure. After receipt of approval from D/O Expenditure, the increased strength of 60 (30 existing + 30 new creation), will be redistributed amongst field offices in proportion to their workload of prosecution/legal work.
